RESCUE - SAINT FRANCIS WOLF SANCTUARY RESCUES CAPTIVE WOLVES AND WOLFDOGS FROM THE EXOTIC PET TRADE -- FROM BREEDERS OR OWNERS NO LONGER ABLE TO KEEP THEM, FROM ABUSE SITUATIONS, OR FROM ANIMAL CONTROL AGENCIES OR SHELTERS WHICH HAVE CONFISCATED THEM. SINCE 2002 SFWS HAS RESCUED 34 ANIMALS, MAINLY FROM EXTREMELY URGENT SITUATIONS AND CONDITIONS OF EXTREME ABUSE AND NEGLECT.

THE ANIMALS' PHYSICAL CONDITION, BEHAVIOR, DIETARY PATTERNS, ETC. ARE MONITORED DAILY AND ANY ABNORMALITIES ARE REFERRED TO THE VETERINARIAN. ANNUAL BLOOD PANEL VALUES ARE ANALYZED TO ENSURE THE ANIMALS REMAIN IN EXCELLENT HEALTH.
